

With Safeco, quoting RV is a snap! You can write RV standalone or on the same policy as your customer's autos. Whether your customers only use their RV for the occasional weekend or are out for weeks at a time, Safeco offers a full range of coverage options.

If the RV is damaged, we'll restore it to pre-loss condition. But, if it's a total loss, Safeco offers three settlement options:

Actual cash value	We will pay the lesser of the actual cash value or the amount needed to replace the vehicle. Rating is based upon the current fair market value of the vehicle.
Replacement cost	We will replace the RV with a brand-new RV valued up to 120% of the original purchase price. May be maintained for 10 years, then switches to ACV coverage. Available for motorhomes and campers.
Agreed value	In the event of a total loss, we pay the agreed-upon value reflected on the declarations page. Available for motorhomes and campers.
